

Chancellor's Measure No. 1/2022, List of Fees

Article I. General Provisions

1. In accordance with Article 10 of the NEWTON University Statute and the current NEWTON University List of Fees (hereinafter referred to as "NEWTON University" or "NU"), the Rector of NU hereby establishes a list of fees (hereinafter referred to as the "NU List of Fees") by directive of the Chancellor.
2. The NU List of Fees sets out the current fees charged by NU related to studying at NU and other services provided by NU.
3. The specific amount of tuition fees is determined by the valid contract between NU and the NU student or the participant in lifelong or continuing education at NU.
4. Specific exemptions, discounts or concessions may be set permanently or for a specific period of time in the assessment of individual fees by means of a decision of the Chancellor. The implementation of such exemptions, discounts or concessions may be dependent on the fulfilment of certain conditions by the NU student or participant in lifelong or continuing education at NU.

Article II. Type of fees and amount of payment


1. The different types of fees, including their specific amounts, are set out in the Attachment to this Measure.
2. For NU students enrolled at NU in Bratislava, in Slovak Republic, and for participants in lifelong or continuing education at NU taking place in Bratislava, in Slovak Republic, specific fee levels in euro currency are calculated (see Attachment to this Measure).
3. For NU students enrolled in the on-linelearning form of the Bachelor's degree programme in Global Business and Management, specific fee levels are applied in the currency in which the price of their studies (i.e. tuition fees) is set according to the study contract they have concluded with NU.

Article III. Permanent discounts and benefits

1. Fees for enrolment in courses beyond the study plan do not apply to students studying under the Premium mode of study or to students of the Global Business and Management English-language programme.
2. If a study applicant or a student has a valid study contract and pays the tuition fees for the following academic year of study no later than 30 June of the calendar year, he/she is entitled to:
 - a. a 25% discount on selected fees charged in the following academic year at NU according to the NU List of Fees (except for the tuition fee itself),
 - b. a 25% discount on other NU products offered in the following academic year that are in the nature of further and supplementary education beyond accredited learning (supplementary courses, recapitulation lessons, trainings, team buildings, etc.).
3. If a study applicant or a student has a validly concluded study contract and is permitted, on the basis of his or her application, to pay the tuition fee for the following academic year in no more than two instalments, the first of which must be paid by 30 June of that calendar year, he or she is entitled to a fee waiver for splitting the tuition fee payment into two instalments.
4. If the binding contract between NU and a NU student or a participant in lifelong or continuing education at NU sets out a price or other more favourable provision for certain fees regulated by the NU List of Fees, the provision of the contract shall be decisive in determining the amount of such fees.

Article IV. Final Provisions

1. The Measure comes into effect on 1 June 2022.
2. On the effective date of this Measure, the previous Chancellor's directive determining fees at NEWTON University, dated on 1 September 2021, is hereby revoked.
