

Chancellor's Measure No. 2/2023, List of Fees

Article I. General Provisions

- Pursuant to Article 10 of the NEWTON University Statute and the current NEWTON
 University (hereinafter referred to as "NEWTON University"; until May 13, 2021,
 operating under the trade name NEWTON College and the abbreviation NC) List of Fees;
 the Chancellor of NEWTON University hereby establishes by means of a
 Chancellor's Measure this List of Fees.
- The List of Fees determines the current amount of fees charged by NEWTON University in connection with studying at NEWTON University and other services provided by NEWTON University.
- The specific amount of tuition fees is determined by the respective contract between NEWTON University and the NEWTON University student or participant in lifelong or continuing education at NEWTON University.
- 4. Specific exemptions, discounts or concessions may be set permanently or for a specific period of time in the assessment of individual fees by means of a decision of the Chancellor. The application of such exemptions, discounts or reductions may be subject to the fulfillment of certain conditions by the NEWTON University student or participant in lifelong or continuing education at NEWTON University.

Article II. Types of fees and amount of payment

- 1. The different types of fees, including their specific amounts, are set out in the Annex to this Measure.
- 2. For NEWTON University students enrolled in Bratislava in the Slovak Republic and for participants in lifelong or continuing education at NEWTON University taking place in Bratislava in the Slovak Republic, the specific fee amounts calculated in euro currency are applicable (see Annex to this Measure).
- 3. For NEWTON University students enrolled in the on-line learning form of the Bachelor's degree programme in Global Business and Management, the specific fee levels are valid in the currency in which the price of their studies (i.e. tuition fees) is set according to the study contract they have signed with NEWTON University.

Article III. Permanent discounts and benefits

Fees for enrolling in a course beyond the study plan are not applied to students studying
in the Premium mode of study or to students of the Global Business and Management
English-language programme. In addition, Global Business and Management students



are not subject to fees for analysis of the possible recognition of courses during the admissions process, change of place of study or change of form of study.

- 2. If a study applicant or a student has a valid study contract and pays the tuition fee for the following academic year of study no later than 30 June of the calendar year, he/she is entitled to:
 - a. a 25% discount of the fees levied during the following academic year at NEWTON University according to the List of Fees (with the exception of the tuition fee itself),
 - b. a 25% discount on other NEWTON University products offered during the following academic year that have the character of further and supplementary education above and beyond the accredited teaching (supplementary courses, rehearsals, trainings, teambuilding, etc.).
- 3. If a study applicant or a student has a validly concluded study contract and is permitted, on the basis of his or her application, to pay the tuition fee for the following academic year in no more than two instalments, the first of which must be paid by 30 June of the calendar year at the latest, he or she is entitled to a fee waiver for splitting the tuition fee payment into two instalments.
- 4. If the relevant contract between NEWTON University and a NEWTON University student or a participant in lifelong or continuing education at NEWTON University contains a price or other more favourable provision for certain fees governed by the List of Fees, the contract shall prevail in determining the amount of such fees.

Article IV. Final Provisions

- This Measure shall enter into force and take effect on 15 March 2023.
- 2. On the date of entry into force of this Measure, the previous Chancellor's Measure regulating the level of fees at NEWTON University dated 1 February 2023 is revoked.
